with Trish Regan. While there, she also anchored a series of primetime specials, including the network's 2012 Presidential campaign coverage. She joined the channel in 2011 and throughout her tenure interviewed some of the most prominent names in business, including: Virgin Group CEO Sir Richard Branson, World Bank President Jim Yong Kim, NSA Director Admiral Michael Rogers, activist investor Carl Icahn, former Secretaries of State Madeline Albright and Condoleezza Rice, former President of the United States Bill Clinton, and CBS Corporation President and CEO Leslie Moonves.

Prior to Bloomberg, Regan served as a markets and documentary anchor for CNBC. She was also a regular contributor to NBC's *Nightly News* and the *Today* show. She joined CNBC from CBS News in 2007, where her work as a financial correspondent for *CBS Evening*

News earned her an Emmy nomination for investigative journalism.

Regan spent time working in the emerging debt markets group at Goldman Sachs and at hedge fund DE Shaw while pursuing a degree in American History at Columbia University. She is a member of The Council on Foreign Relations.

Environmental and Regulatory Affairs Committee Meeting Report

ERAC held its third meeting of the IPMI calendar year at the Annual Conference in Orlando. The meeting was designed as a meet and greet with the intent on broadening the committees appeal for IPMI members. This was held in concert with the relatively new EHS Committee. Our objective was to highlight the historical accomplishments of ERAC; delineate the approach of the combined committees; and speak to current issues. Larry Drummond and Elba Lizardi gave presentations on the aforementioned topics. Some good discussion ensured with the attendees.

Current ERAC Initiatives:

Department of Commerce: We are members of ITAC 9, a Department of Commerce industry advisory group. At the President's request, ITAC 9 has submitted a number of proposals to improve NAFTA. IPMI has published the letter and it is available from Sandra Arrants. It focuses on enforcement and on leveling the impact of the treaty, particularly the use of Canada and Mexico by other countries to transship metals illegally into the US.

Department of Treasury: IPMI has represented the precious metals and stones industries in the Treasury Dep[t/FinCEN Bank Secrecy Act Advisory Group for over 10 years. Items of note include:

- A proposed law requiring States to collect and maintain beneficial owner information,
- Sharing information regarding suspicious activity,
- Banks' proposal to revise regulations.

Enviornmental Protection Agency: This year, IPMI was appointed to EPA's committee on inorganic byproducts. This puts IPMI in ongoing contact with the EPA on a permanent committee. Gus Ruggiero of Johnson Matthey is our representative. One objective is to clarify and eliminate conflicts in the regulations. Areas to be considered include:

- Process for inorganic byproduct reporting including redefined chemical substance categories and modified process and use information
- Expansion of chemical extraction exemption for byproducts under 40 CFR 711.10 to include inorganic chemicals reacted as part of chemical extraction process
- Limit reporting requirements for recycled inorganic byproducts ("IBRs") to Parts 1 and 2 of the CDR Reporting Form U, while enabling EPA to identify specific IBRs for reporting

 Exemption for byproducts that are recycled, reused or reprocessed at the facility at which it was made into a commercial product or at a different facility, but then returned to the original facility.

Made in America: IPMI has joined with Richline Industries, the largest US jewelry wholesaler, to pass legislation that will change the standard for labeling goods "Made in America." Currently, the FTC's regulation requires that "all or virtually all' the contents of an item must be from the USA. This precludes nearly all precious metals items from using the "Made in America" label because the origin of precious metals in scrap can seldom be identified. We are working to change the standard to "substantial transformation," and to permit both (1) bullion refined in USA irrespective of the origin of scrap contained and (2) items manufactured in the USA irrespective of the origin of metals contained, to be lableled "Made in America.

- 4. Even though you were selected as an IPMI scholarship winner, all submissions are peer reviewed by the Journal review committee, so high quality is paramount.

Retirement Celebration Held for Fred Saada and Mabel Accurso





2015 IPMI NY Metro Student Award winner **Nerissa Lewis** informs us "On 03/16/17, I successfully defended my dissertation entitled 'N-Donor Ligands as Potential Linkers for Bioconjugation.' Then on 05/12/17, I graduated from LSU with my PhD in chemistry. I will be joining the chemistry department at Walla Walla University in Washington as an assistant Professor on 08/01/17."



Meanwhile, 2016 Gemini Industries Graduate Student Award winner **Yuxiang Chen** updates us with, "I will be graduating this August with a PhD degree in chemistry from Carnegie Mellon University. After that, I will be a director's postdoctoral fellow in Los Alamos National Laboratory. The most exciting scientific achievement after the IPMI conference last year is that we published a Science paper in December 2016, titled "Emergence of hierarchical structural complexities in nanoparticles and their assembly."
